**A ROADMAP FOR THE  
FUTURE OF JUVENILE  
JUSTICE IN MINNESOTA**

The Minnesota Corrections Association MCA developed and conducted a juvenile justice survey among *Juvenile Justice 21* forum participants and other juvenile justice professionals in October 2014. The survey was conducted online via web based survey tools by an independent research consultant based in Northern Virginia. The survey was sent to all forum participants that either registered or attended at least one of the ten Juvenile Justice 21 forums hosted by MCA between May and September 2014. In addition, the survey was sent to contacts for 28 statewide juvenile justice related organizations.<sup>1</sup>

226 Respondents completed the survey. Sixty-five percent attended one of the forums and thirty-five percent did not.

One of the survey questions asked the respondents to “Please tell us about the best juvenile delinquency-related program(s) in your area.”

Below are the answers to the request organized by county where the respondent works. It is hoped this will provide a snapshot of some of the good juvenile justice programming occurring throughout the state.

<b>County Where Responent Works</b>	<b>Please tell us about the best juvenile delinquency-related program(s) in your area.</b>
Aitkin	Kids Plus- provides prevention, intervention, family programming, school and community support resources and advocacy to juvenile offenders and kids at high-risk for delinquency.
Aitkin	1 juvenile agent for our county to supervise diversion, restorative justice (with the help of 2 volunteer facilitators) and juvenile probation. Limited resources in our county. Fairly standard supervision. Use of online classes for Chem. Educ and shoplifting. Excellent collaboration between agencies in our county which is a valuable resource and huge help.
Anoka	Anoka County Juvenile Programs; Acres for Life; Aftercare Program; In-home family counseling
Anoka	North Star Juvenile Diversion Program-pre-trial program provides first-time offenders with an alternative to juvenile court. The idea is to maintain a positive environment to reduce recidivism
Beltrami	Restorative justice program allowing juveniles and victims to sit down, mediate and heal
Beltrami	North Homes Inc. (Grand Rapids, Bemidji) MCF-Togo (ThistleDew)
Beltrami	We are currently implementing the Dually Involved Youth procedure here in Beltrami County. Our procedure is unique considering we are working closely with both the Leech Lake and Red Lake Tribes to ensure all children in Beltrami County are properly served.
Blue Earth	Archer alcohol/drug education programs in schools
Brown	Juvenile Treatment (drug & mental health) Court. ISP (Intensive Supervision Program) Diversion/Teen Court
Brown	Teen Court here is an excellent program for first time petty and certain second time offenders. Been in operation since 1998.
Carlton	Carlton County Restorative Justice Program - diverts almost all youth crime in the county to the RJ Program. Low recidivism rate since program inception, reduced out-of-home placement costs, involves victims of crime at a deeper level, engages community to become aware and partake in crime reduction opportunities, holds youth accountable through restorative approaches.

Carlton	AJC-offers cognitive skill Programming; Woodland Hills- offers residential programs with transitioning into community included; ThistleDew offers programming in a wilderness setting.

Cass	Cass County partners with the Leech Lake Tribal Court on Diversion and other juvenile related matters to address DMC.
Cass	In our area, I would think it is the NW MN Juvenile Center in Bemidji, MN. They run very good programming.

Chippewa	CIRCLE sentencing in Yellow Medicine and Chippewa counties. The youth's case is placed on "continuance for dismissal" status and he/she is referred to the CIRCLE program. The program involves meeting (usually every two weeks) with community volunteers who discuss the delinquency and its consequences. The CIRCLE also gives the youth "conditions" (school, community service, apologies, restitution, etc.). The meetings include at least one parent/guardian, so the family of the youth is involved with the diversion, because the CIRCLE can also address family dynamics and home life that may be contributing to the delinquent behavior.
Clay	Clay County Re-Entry Services
Dakota	Our juvenile work crew is a good experience for kids because the corrections officers who run it somehow make the kids feel competent and valued - plus restitution to victims is earned by them through their hours.
Faribault	Faribault County is currently working on creating a truancy panel that involves several systems in our communities that work with children. Currently, we have monthly Local Coordinating Council meetings at each school. The meeting involves the youth, parent, school resource officer, principal, social worker, and human services. The youth's grades are reviewed, how things are going at school and at home, and a plan/goals are made for the youth to strive to achieve within the next month. We have a mentoring program in Blue Earth for youth to work with a mentor.

Hennepin	Hope Street is not solely juvenile delinquency based, but are heavily involved in the downtown 100 project for 18-21 year olds. They are doing amazing work across the board for at risk and homeless youth.
Hennepin	(1) The Legal Rights Center partners with the Minneapolis Public Schools to implement a restorative intervention in response to behaviors leading to a recommendation for expulsion. This family group conferencing restorative model has proven to be very effective as a response to serious behavioral incidents, including assaults, weapons and drugs. Research by the University of MN found significant positive impacts on attendance, credit attainment, and student engagement, and significant reductions in future behavioral incidents. This model is much more effective than court involvement in dealing with these behaviors, and does not result in the significant collateral consequences of court involvement. (2) The Minneapolis Police Department has worked with community partners to implement juvenile diversion. Juvenile cases are reviewed by an MPD officer using standardized criteria to determine if the juvenile is eligible for MPD diversion. Eligible youth are offered an opportunity to participate in diversion programming, including restorative practices, mental health services, and case management services. Data on all cases reviewed is being tracked by MPD to examine racial disparities, opportunities for expansion, and effective diversion practices.

St. Louis	The use of the RAI (Risk Assessment Instrument) prior to placement of a juvenile into a detention facility. This prevents the unnecessary placement of a juvenile in detention. The PSC (Probation, Social Services, and Community Members) program. This is a program that works with families identified as high risk. The goal is to provide wrap around services to create a healthy home environment where juveniles can succeed as they transition home. There is a need for more programs like this, greater funding, and more staff to extend this program to more clients though.

YAP, with the assistance of MAP, has allowed for more opportunities for diversion for youth in St. Louis County. ARC corrections also offers a Drug and Alcohol Program for children charged with underage consumption.

Stearns	Crossover youth
Stearns	Stearns County has been implementing a "Crossover Youth" program for several years now and we have had several positive outcomes. We have broken down several of the "silos" between departments and agencies that are the barriers to the integration of effective services. We have been able to keep several juveniles with mental health, family stability or other CHIPS-type issues from entering or going further into the juvenile justice system with this program. It is still a work in progress, but the current results have been overwhelmingly positive.

Washington	We utilize MultiSystemic Therapy, an in-home family therapy intervention. We have good success with this approach.

Wright	1. We have a very ambitious diversion program, allowing youth a second chance 2. Prevention- we have a collaborative effort in place called "wRight Choice" which provides a safe place for school suspended youth to keep up with academics, and participate in restorative justice to provide a process to "correct the harm", in lieu of going home, being unsupervised, and not owning their behavior.
Wright	Village Ranch Inc. - Helps families and individuals through therapy, group home setting, and skills workers.
Yellow Medicine	YMC has implemented for the past 10+ years a Restorative Justice Program surrounding Circle Sentencing, Family Circle(for CHIPS/Family cases) and Circle of HOPE(people in recovery). We have seen a reduction in out of home placements and better outcomes for futures of youth, less recidivism. We have an active diversion program and make collaboration on the outcomes of cases a priority with all our ancillary agencies (ie: county atty, PD, probation, Family Services, RJ department)
