MCA JJC meets monthly, every second Thursday of the month at the DOC Central Office in St. Paul. Thus far in 2016, our committee has held eight meetings addressing a variety of juvenile justice issues detailed below.

One of our committee's major goals for 2016 involves a commitment to a follow-up to the JJ21 (Juvenile Justice) Project coordinated by Mark Haase in 2014. The 2014 JJ21 Project consisted of eleven forums held throughout the state, inviting stake holders (PO's, SW's, attorneys, judges, school personnel, legislators, etc.) for their input on issues needing attention in juvenile justice. Findings from the 2014 JJ21 Project determined six significant issues in juvenile justice across the state (see JJ21 2014 Report). As a follow-up to the 2014 project, JJAC agreed to fund efforts to create a tentative working plan for JJ21 in 2016, outlining an Advisory Group (consisting of JJC and JJAC members, meeting 2-4 times in 2016, including input via email/phone). At the initial advisory group meeting in February 2016, the group selected two of the six issue areas to address in 2016; deciding 1) *Mental health*—improving and expanding mental health and chemical dependency diagnosis and treatment and 2) *Crossover youth*—improving collaboration between juvenile delinquency and child welfare systems to support youth and their families jointly. Two forums were held in May 2016, discussing mental health/substance abuse and crossover youth research, trends, and tool kits for practitioners in the field. Findings from the forums and additional surveys to stake holders are planned to present models for addressing mental health/substance abuse and crossover youth resulting in a report, which would later be submitted to the legislature. The JJ21 2016 Project is projected to be a three year project, addressing all six juvenile justice issues, two each year, with finding reports to the legislature.

Also this year, JJC collaborated with MCA Adult Legislative Committee to review and provide input on juvenile issues in the legislative agenda draft for 2017. JJC supports elimination of the mandatory sentence of LWOP for juveniles, revision of the juvenile POR, and added language addressing juvenile issues in mental health and substance abuse.

Throughout our JJC meetings, committee members are free to discuss and propose juvenile justice issues deemed in need of attention. This year one of our committee members proposed looking into talks at the DHS level regarding placement beds around the state. We are finding our juvenile clients are on extensive waiting lists for (6-7 months) residential treatment and (2-3 months) for corrections programs. We are experiencing particular struggles with juveniles who have significant mental health issues with aggressive behaviors. Agents are having to seek out of state placements for youth or having to place youth in programs that are unable to meet their extensive needs, often resulting in more legal charges.

Legislative Liaison Cal Saari

2016 was the second year of the biennium and as we reported, we didn't think much would happen in the Legislature and proved to be the case. Legislative sessions did not start until March and it was a very quick session. At the start of the year, we attended several joint sessions of the House Public Safety Committee and the Senate Judiciary Committee as they were looking at changes in the sentencing guidelines. Another group, the Prison Population Task Force, also conducted hearings and looked at various solutions to the prison population issues. During the Session however, neither the House nor the Senate showed much interest in moving any of the proposals forward. Everything kind of lingered through the Session and in the final few weeks a group got together and eventually agreed on some changes to the sentencing guidelines, particularly as they impacted drug sentences. In fact, our Legislative Update Workshop at the Fall Institute on Wednesday afternoon will feature key people in that compromise language work group. Commissioner Roy, Mark Haase and Sarah Walker will lead the discussion and talk about the impact thus far of that legislation.

Other than that, it was pretty much a "do nothing legislative season". The polarization within the two party system led to gridlock at the end of the Session and the Legislature wasn't even able to pass a bonding bill even though this was the typical year for passage of a bonding package. Instead, the party leadership of both major parties pointed fingers at one another and decided to go home and campaign for re-election! Even several attempts to bring about some agreement on a bonding package through a special session fell through, until finally it was just too late in the year to make that effort possible.

Another high note took place on March 1st at the DOC Central Office where we held a Legislative Update Session that included presentations from several Legislators from both parties, and the leadership of the House Public Safety and Senate Judiciary Committees. This session was very well attended and overall feedback was very positive. We did hear from a number of folks though, that although this format worked well, they hoped we would return to a special breakfast meeting during the Session as we have done in the past. The MCA Legislative Committee has also had this discussion and that this point I think we may return to the breakfast session sometime early in 2017.

2017 will be the beginning of a new biennium with the Legislature reporting on January 3, 2017. The November elections will be upon us shortly and we anxiously await for the results to see which party will control the chambers of the House and Senate and work with the DFL Governor Mark Dayton. A new biennium brings new people to the floor of the Legislature, and a certain enthusiasm to those of us who work on your behalf at the Legislature. The MCA Legislative Committee will be presenting our 2017 Legislative Agenda at the Fall Institute where we look for feedback from our membership. Once the agenda is finalized and approved by the MCA Board of Directors, I will begin my personal contacts with Legislators, particularly those who will serve on Public Safety/Corrections/Judiciary Committees to assure that they are well informed of our organization and what our priorities are.

I want to thank MCA, its Board of Directors, and the many committee members for giving me the opportunity to work on legislative issues on your behalf. I'm excited again to have another new Legislature in our future and with your continued support, we'll aggressively continue this work on behalf of our members.
